All vehicles will be accepted starting **OCTOBER 14<sup>th</sup>** between **8:30 AM & 4 PM.**

***Once a vehicle has been stored, it is not accessible.***

Vehicles can be removed on Saturday April 26<sup>th</sup> and Sunday April 27<sup>th</sup>. Between the hours of 9am-5pm. All vehicles must be removed by 5pm on APRIL 28<sup>th</sup>, 2025.

***Overall length includes trailer hitch, outboard motors and propellers where applicable.*** Be advised: All vehicles will be measured on arrival and any overages must be paid before acceptance for storage.

All batteries must be disconnected and propane tanks removed. Keys must be left with vehicles.

**ALL CANVAS TOPS AND BARS MUST BE LOWERED ON BOATS.**

Storage rates include required NYS Sales Tax.
